§4155. Certificate and attestation - No appeal or suit pending

When no statutory appeal as provided by law from the appraisal of the Listers and no suit to recover taxes paid under protest is pending on the first Tuesday of February following such lodgment, the Selectboard and Listers of a town or the mayor and assessors of a city shall endorse a certificate to that effect upon the grand list and the same shall be attested by the town or city clerk with the date of such attestation.

§4156. After appeal and suit determined

When any such appeal or suit is then pending, such certificate shall be made as soon as such appeal or suit has been finally determined.

§4157. Effect of such certificate

From the date of endorsing such certificate upon the grand list as aforesaid to the effect that no such appeal or suit is pending, when offered in evidence in any court in this state, such list shall be received as a legal grand list of such town or city and its validity shall not be put in issue by any party to any action in any hearing or trial in any court.

The legal voters of the Town of Thetford are hereby warned to meet at Thetford Town Hall in said Town on Tuesday, March 2, 2021 to transact the following business by Australian ballot:

Article 1	To elect all Town Officers required by law:  Town Moderator  Selectboard member for a term of three years  Selectboard member for a term of two years  Lister for a term of three years  Cemetery Commissioner for a term of three years  Cemetery Commissioner for a term of one year to complete a term of three years  Trustee of the Public Trusts for a term of three years			
Article 2	Shall the voters authorize payment of real and personal property taxes on Friday, October 15th, 2021 by physical delivery to the tax collector before 5pm on that date?			
Article 3	Shall the town set the penalty charged by the collector of delinquent taxes for payments made after the due date for payment to four percent of the tax for the first fifteen days, and then an additional four percent of the tax for the sixteen day and thereafter pursuant to 32 V.S.A. § 1674(3)(B)?			
Article 4	Shall the voters authorize general fund expenditures for operating expenses of \$1,628,543 of which \$1,248,649 shall be raised by taxes and \$379,894 by non-tax revenues?			
Article 5	Shall the voters authorize highway fund expenditures for operating expenses of \$1,409,870 of which \$1,275,470 shall be raised by taxes and \$134,400 by non-tax revenues?			
Article 6	Shall the voters appropriate \$116,190 to the Thetford Library Federation for the purpose of providing library services to the town?			
Article 7	Shall the voters appropriate \$302,410 to the Thetford Volunteer Fire Department for the purpose of providing emergency services to the town?			

Article 8 Shall the town vote to give the Selectboard general authority to enter into tax

stabilization contracts with owners, lessees, bailees, or operators of agricultural or forest property, open space land, and alternative-energy

generating plants, pursuant to 24 V.S.A. § 2741(b)(1)?

Article 9 Shall the town give the Selectboard general authority to enter into tax

stabilization contracts with owners, lessees, bailees, or operators of commercial or industrial property, pursuant to 24 V.S.A. § 2741(b)(1)?

The preceding Articles shall be voted on by Australian ballot on Tuesday, March 2, 2021. The Australian balloting will take place between 8am and 7pm at Thetford Town Hall, 3910 Route 113, Thetford Center, VT.
