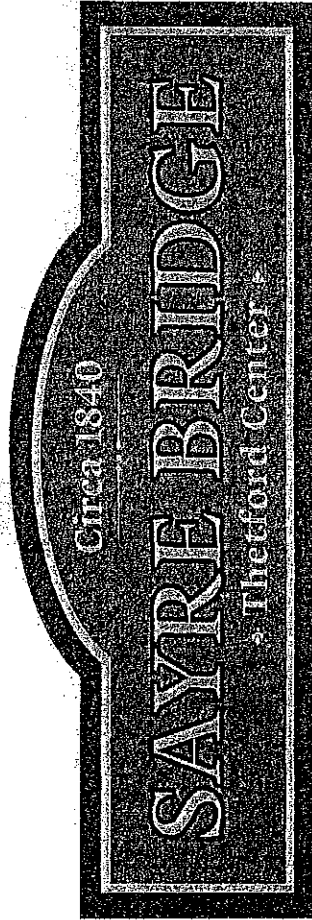

Re: Conditional Donation, Thetford Planning Commission Recording Clerk Position 2021

I am writing to convey an offer to the Town; I request that the Thetford Selectboard accept a conditional donation to be used to fund a stipend for the Thetford Planning Commission Recording Clerk position for the 2021 calendar year.

Given the proposed elimination of the TPC Recording Clerk stipend in 2021 – and considering the critical nature of his role during the Thetford Zoning Bylaw review and revision process that will unfold over the upcoming year – I believe it imperative that the current Recording Clerk receive compensation consistent with his involvement in this Planning project.

I propose that the Recording Clerk be paid the sum of one hundred and forty-one dollars (\$141.00) per month (\$1700.00/12 months), with a final December 2021 payment of one hundred and forty-two dollars (\$142.00). Note that the Town Manager (both previous and current) have agreed that the Town will pay for the five (5) hours the current Recording Clerk put in before he was notified that the position's stipend was to be eliminated. As a gesture of good will, Mr. Whitlock has agreed that the conditional donation may be used to pay for the aforementioned five (5) hours.

This donation is contingent on Thetford's agreement that the donated monies only be used to pay the stipend to the Planning Commission Recorder for the calendar year 2021. The full annual amount of the conditional donation stipend amount will be paid by means of a personal check written to the Town of Thetford, Vermont prior to any initial dispersal.

Thank you for your time and consideration. Please reply to this conditional donation offer at your earliest convenience, following whatever legal and administrative tasks arising from this offer are deemed requisite. Note that Thetford Town Clerk Tracy Borst has suggested this donation be listed under Miscellaneous Receipts 100-2990-00.00, in tandem with the Thetford Deposit Request form.

Sharon Harkay called the meeting to order at 7:01 pm.

Agenda changes: Sharon said it had been brought to her attention that they need to re-do the votes from last Monday's meeting as they all need to be voted by roll call. Sharon suggested doing this right after public comment.

1 Sharon felt it would feel more like a retreat if the Selectboard could be in a single room. The
2 concern was whether other people would have to be let into the building if they showed up at
3 Town Hall, but the Selectboard would not be obligated to do that if the meeting was warned as a
4 virtual meeting. COVID-19 protocol will be followed with members wearing masks and staying
5 6' apart. Selectboard members agreed that they would like to be together as most will be
6 vaccinated by then. Nick Clark said he did not plan on attending.

7 **Motion** by Mary Bryant that members of the Selectboard, on April 12th, meet at the Town Hall at
8 7:00 pm for the annual retreat and live-Zoom it for community participation. **VOTE** by roll call;

17 Sharon reminded people that they would not be taking any public comment during this
18 discussion, but perhaps they would take questions. Sharon said she didn't want to get into people
19 telling the Selectboard what should be done with the land, or what the use of the land should be
20 because there has been lots of input from residents already.

21 Sharon said there were originally two parties that submitted purchase and sales contracts for the
22 property on Route 244 in Post Mills. As of today, one party has withdrawn their offer. Steve
23 asked if he understood correctly that one party raised their bid price. Sharon said that was
24 correct.

25 Motion by Sharon Harkay that the Selectboard accept the purchase and sale contract as put forth
26 by John D Freeman and Jeannette B Freeman Trust, pending approval of Town Counsel.

27 Nick Clark said he was concerned about the outstanding Open Meeting Law violations that relate
28 to this matter and didn't feel comfortable voting on this now.

29 Sharon said she has sent out one email to the Selectboard stating that she would like to have this
30 discussion in open meeting vs. in executive session. Sharon said that they should not reply all,
31 believing that prevented it from being a meeting. Nick has pointed out he felt it violated the
32 Open Meeting Law. Sharon spoke with Town Counsel who said if the emails are put into the
33 minutes of this meeting, they would become public record. Sharon read the email out loud.

34 *PLEASE DO NOT REPLY ALL*

35 *This is going to be the major topic for our meeting on the 15th. I wanted to let you know that I*
36 *would very much like to have this discussion in open meeting rather than executive session. We*
37 *should have to say the names of the people. We can refer to proposal 1 and proposal 2. Know,*
38 *too, that I am not going to allow public comment during the discussion because the public has*
39 *had ample opportunity to let us know their thoughts, and a lot of people have expressed*
40 *them. Please let me know whether or not you're comfortable with the idea of not going into*
41 *executive session for this.*

1 *I knew there was something that didn't sit right with me, and now that our meeting is over, I*
2 *remember.*

3 *It was the cow farmer who hays that field on Rt 244. When he heard the land might be developed*
4 *he said if he could no longer cut hay there he would have to purchase hay. There was nowhere*
5 *else within driving distance where he could get permission to cut. Doesn't sound like big deal to*
6 *us, but to a farmer, always struggling to make ends meet, it is another nail in the coffin.*

7 *In 1947, Vermont had 11,206 dairy farms. By 1990, the number had declined to 2,370, and in*
8 *2008, only 1,097 dairy farms remained. Vermont continues to lose dairy farms every year. in*
9 *2020 AP News reported that there were about 677 remaining, with the smallest operations*
10 *taking the biggest hit.*

11 *One of the issues that came up repeatedly in debates over the Rt 244 field was the fact that the*
12 *land is 'Ag soil.' Although it is not Prime Agricultural soil, it does have the Statewide*
13 *Agricultural designation. Keeping agricultural land in farming is key to to the long-term*
14 *sustainability of Vermont and New England's food system, especially as climate change*
15 *threatens agriculture in other parts of the US. Every hayfield counts*

16 *However statistics show that from 1982 to 2012 Vermont lost more farmland than any other*
17 *state in New England:- 322,728 acres (a 20.5% decrease). (Much of it to development.)*

18 *It does not sit well with me that people from _____ however well-meaning, can just come with a*
19 *lot of money and take this hayfield out of production. They probably love seeing local dairy*
20 *farms, an icon of the Vermont landscape. But they don't understand that their plans for this field*
21 *are just one more of the 'thousand cuts' that are slowly killing Vermont agriculture.*

22 *It does not sit well with me that they would use the field just to play at having a business,*
23 *because, if they can buy the land with cash, they don't need to make money at all. But that*
24 *farmer very much does need to make money, and taking away the hayfield incurs a genuine*
25 *hardship.*

26 *And making labeled wildflower plantings smacks of rural gentrification. It is an impractical use*
27 *for good land that presently contributes to the agricultural economy.*

28 *In spite of the comment about the Town Garage (made AFTER the Town had purchased the*
29 *field) _____ understands the need for haying and he knows the farmer, as do people in the*
30 *community. I trust they will not let him down. If we can't have workforce housing there, let's at*
31 *least do what we can to protect agriculture. It's the responsible thing.*

32 *Thanks for your patience,*

35 Sharon said perhaps before they took a vote on the motion on the floor that perhaps she should
36 make a motion to accept these two emails into public record. Nick said there was another email
37 that Mary wrote.

38 Steve wondered if an omnibus motion could be made that would take into account any emails
39 that may have been called into question as violating the Open Meeting Law and allow the Town
40 Attorney to review them and then they can be sent to Martie to be put into public record.

41 Li said she believed the Selectboard needed to cure this matter at the current meeting, as it is the
42 meeting when they are deciding the fate of this land.

43 Sharon said the attorney already advised her that she needed to have her email read out loud at
44 the meeting.

1 Nick said that first the Selectboard had to determine if a violation occurred and then they have to
2 cure the violation by making that information public. The Selectboard hasn't determined
3 anything yet, they just started reading emails out loud.

4 Sharon said the attorney said just today, that the Selectboard could go ahead with discussion on
5 the land and a decision to accept an offer could be made because the agenda item was legally
6 warned. Sharon quoted the attorney that "there was no legal reason to prohibiting discussion of
7 this matter". Li said that Nick had written out in quite some detail why these things were a
8 violation and that she assumed that they were abiding by what he wrote as he understands
9 statute. Li said she can find an email she wrote if Nick is agreeable to being quoted. The attorney
10 has already reviewed all the concerns that Nick brought forward, and Sharon spent some time on
11 the phone with him, going through all six complaints. Sharon said the attorney ruled on all
12 emails and Sharon is acting according to what the legal counsel has advised. Sharon said that the
13 attorney did not have any reason for concern about Li and Mary's emails.

14 Alexis Jetter said this is a great moment for this Selectboard to assert that these are emails that
15 are well thought out, they add to the public understanding, and they really enhance the historical
16 sense. Alexis thought Li's email was important for us to hear. If attorney has said it's not a
17 problem, this is setting aside Nick's concerns which are important to consider, let's not do the
18 default of kicking it to the attorney. Here's an example of something that's happening right now.
19 You're taking your vote right now. All of the concerns that everyone has expressed are coming
20 to a head right now. Please show us at this moment, that you will take the importance of this
21 community and make that a priority. Alexis said she hoped it would be their instinct and that she
22 trusts that's what they want to do. Alexis would like to hear Mary's email, or any of the others
23 that the attorney said were of no concern.

24 Mary read her email out loud.

25 *Hi All,*

26 *I think Li and I had some of the same thoughts relating to Friday's conversation of the Post Mills*
27 *Land. I too would like us to reconsider our method for selecting a bid for the Post Mills land.*
28 *One of my thoughts is that we represent our constituents' voices and use the majority voice*
29 *to guide our decisions as a general rule.*

30 *It was clear to me at the community forums that P.M. wants the hay field to stay a hay field. We*
31 *worked with them in good faith. On several occasions we stated that if we did not build houses*
32 *we would sell it back with the covenants for 2 housing lots. We also told them that the price*
33 *would cover our expenses, we said nothing of a highest bidder.*

34 *If we go for the highest bidder, we are breaking our word to P.M. residents. That could be seen*
35 *as a biased decision if we sell to the one with the highest \$ amount. Working with our*
36 *community is not solely business. Community is the people, businesses, environment, values and*
37 *the greater good.*

38 *If I/we think of the constituents' voices first over one or two perspective buyers is that*
39 *being biased?*

40 *I very clearly heard what the P.M. people value and it is not simply \$\$\$\$.*

41 *What I heard from the 120 PM community residents that came to the forum was they value and*
42 *LOVE that little 7.8 acres. They do not want it developed, period.*

43 *Comments from PM community:*

44 *- want open land open land*

6 They also value that 7.8 acres as a hay field for a local farmer. As Li said he may not be able to
7 make it if he does not have access to this field. It represents between \$5,000 to \$7,000 of either
8 income and or not having to spend \$ to buy hay. He has an investment in his machinery as well
9 as ag land. Vermont has lost over a hundred farms in the last few years and such a small few
10 remain compared to the old Vermont.

11 I have never heard constituents say they need more ice cream options or sandwich places. But if
12 the Calls would like to have a shop somewhere in the village center or some where else in town
13 (Isabelles) that would be even better zoning wise than having it out on 244. Once the hay field is
14 gone it is gone. There are other locations for a cafe than 244.

15 I am very happy we took time to make a decision, and not make one last Friday. I would
16 appreciate a discussion on May 8th to reevaluating our process and criteria for making this
17 decision.

31 are coming to the end of it, but it has been a process that has been difficult at times. Mary said
32 she would like to thank the trust who gave the Selectboard the money to purchase the land in
33 good faith. They sacrificed money that has not been invested over this last year, so thank you for
34 that. Mary would like to thank the more than 120 people who came out to the 2 forums to voice
35 their opinions, because that is democracy and we heard you. She would also like to very much
36 thank all the people who put in bids, and without going into detail, all of them had the best of the
37 community in mind; and she appreciates all the ideas and thoughts that they brought forth. Mary
38 said she thinks they have ended up in a good place.

39 Sharon said she thinks she can add that the closing date on or before April 16th, if the attorney
40 accepts the contract.

41 Nick Clark said he thinks it is clear that some members of the Selectboard have been having
42 substantial discussion outside of open meetings, and most of the residents here only discovered
43 that tonight. In the same stride Sharon stated both in an email to the Selectboard and at the
44 beginning of this meeting that there would be no public comment. I know that this has been a

1 trying process but one of the most important things we have learned from the residents was that
2 they wanted the Senior and Affordable Housing Committee to be more transparent and they
3 wanted the Selectboard to be more transparent. It is the end of process, but even now it is evident
4 that transparency isn't completely happening. Nick said he does not think the public should be
5 prohibited from commenting, especially since there have been new deliberations presented by
6 Selectboard members that the public has never heard before.

7 Alexis asked if the Selectboard knew anything about what the new owner has proposed to do
8 with the land.

9 Sharon said they did know, and Li said that information would be made available when it's all
10 squared away. It's not a terrible secret but the Selectboard is being very cautious.

11 Sharon said the public will be happy.

12 **VOTE** by roll call; Mary Bryant – in favor, Li Shen – in favor, Steve Tofel – in favor, Nick
13 Clark – abstain, Sharon Harkay – in favor

14 Sharon checked with the Town Manager to see if he would send it on the Town attorney and then
15 once the attorney reviews it, they can announce what will happen with the land.

16 Nick said once the Selectboard votes on it, it becomes public record so it can be announced.

17 Sharon said that the Jeannette B Freeman trust is providing the financing for Brian Ricker, and as
18 many people know Brian will maintain it as a hayfield and at some point, hopes to build a new
19 home there.
