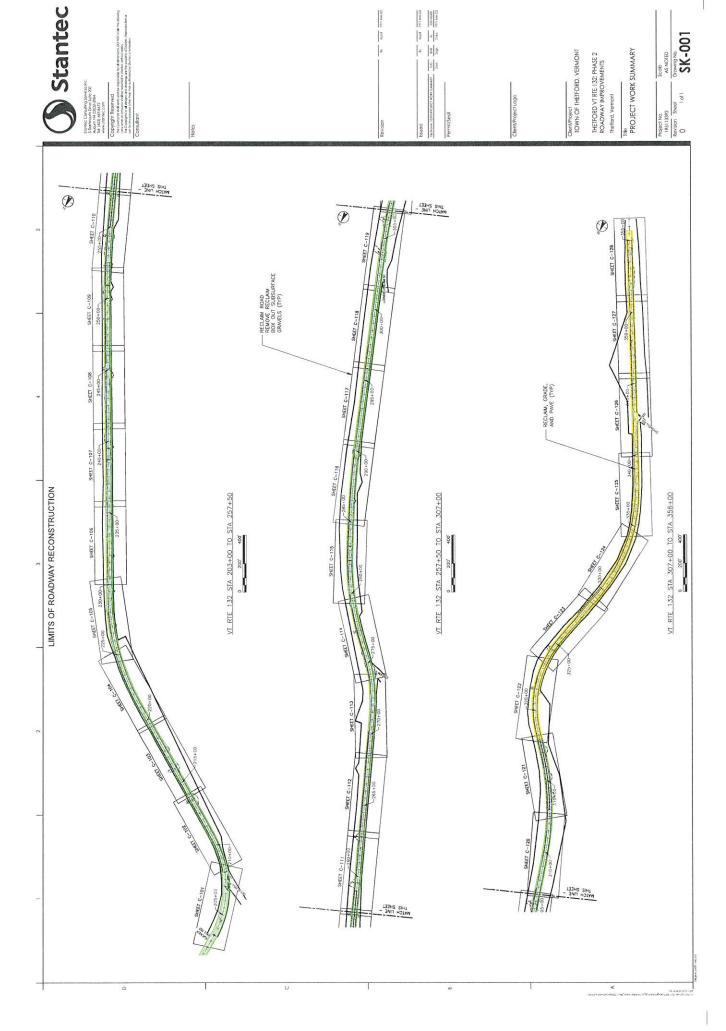

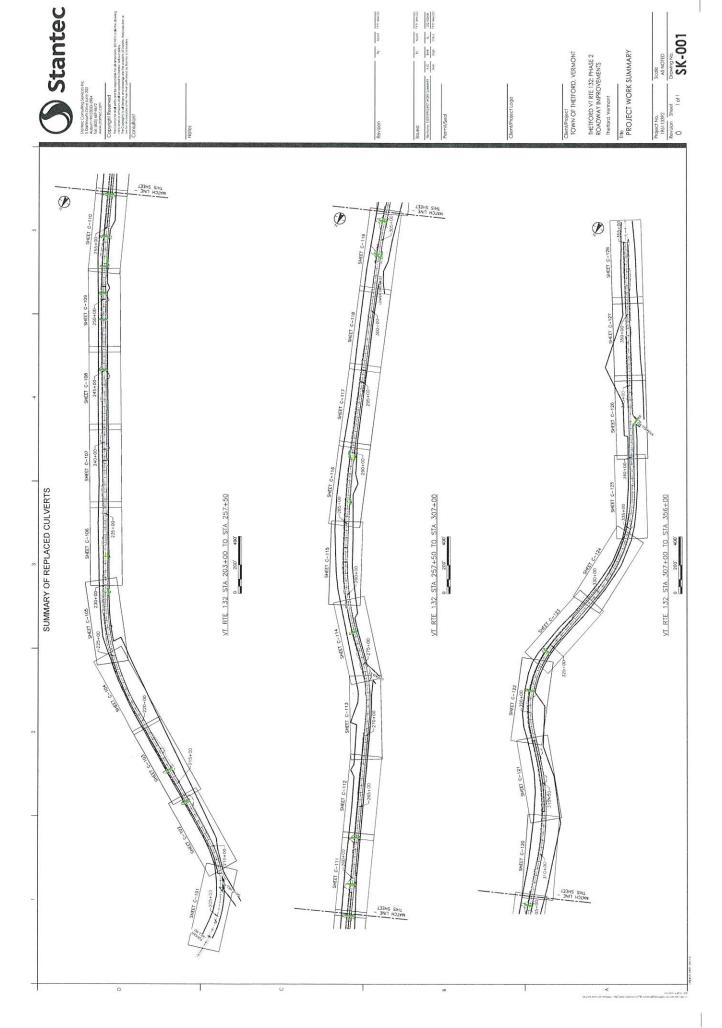

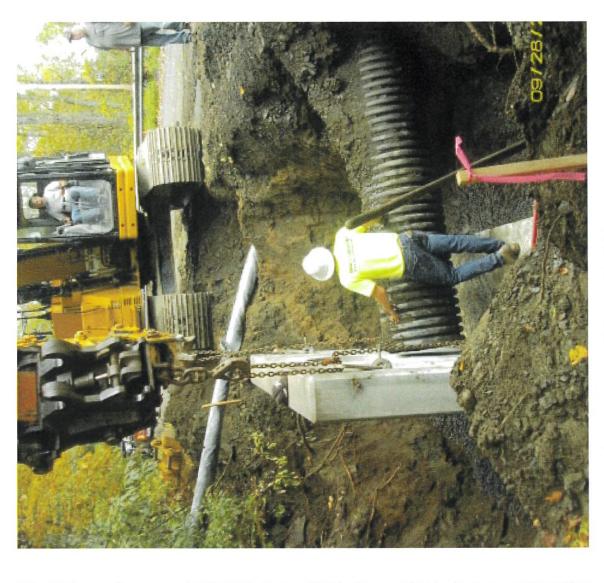

# • Personnel Update

Bonnie Weiss explained that she always files her taxes, including the HS-122 and I-144. This year she filed her taxes on March 1st. # 5. Introductory Presentation with Tina Foster of Brian Boland's Estate/Post Mills

Tina Foster introduced Dan Mullen, an attorney she has been working with concerning the estate of Brian Boland. Tina said that Brian Boland's will states that he is bequeathing the airport to the town, with a life estate for Tina at the airport. This bequest was made with the restriction that it is used for small aircraft and balloons. If for some reason it could not be used for that, the property should remain as open space for recreation. The remainder of his estate and property is equally distributed between Tina and the town. Tina has been named as the executor of the estate.

Dan Mullen with Sheehey, Furlong and Behm, said the airport is offered to the town, but if the town is unable, unwilling or disclaims the property, (upfront the town has the right to not take the property), in such case there is a pecking order on how it would be passed along. If the town takes the property, and if at any point the property can't be used as an airport, it will remain as an open space for recreation.

32

Tina went on to explain that a group of pilots who use the airport, and the Post Mills Soaring 33 34 Club are very interested in seeing it remain an airport. There has been a group of people who 35 have been working on keeping operations going. (Several of these people were at the meeting) They are hoping for a way to keep the airport operational or as a space that is an airport but 36 welcomes people from the community to visit and enjoy the museum. Tina spoke of her hope to 37 38 expand on other opportunities.

39 Sharon asked about the bus that Brian had wanted to turn into a diner. Tina said the diner was not a tenable thing, but it has been made smaller and turned into a stage. While it's not road worthy, 40

it can be driven around the airport. Tina said she has been working on hard on the finances. If the 41 town decides to take the property, the piece that is complex will be determining what that looks 42

43 like.

44 Sharon asked if Tina would like to expand on the split of the rest of the estate.

- 1 Tina read the will, "All the remainder of my estate and property of every kind and description,
- and wherever located, real and personal, as follows; one half shall be distributed to Tina Foster,
- 3 the other one half to the town of Thetford, to be used on the same terms as provided above for
- 4 the airport." Tina said there is also a condition in the will that she pay all real property taxes, and
- 5 that she maintains and keeps up the residence. Tina said she would hope that whatever the split
- 6 would look like, it would be good for both her and the town.
- 7 Sharon said she wondered if the estate included any funds that would help the town cover
- 8 expenses that might be incurred if the town does accept the airport.
- 9 Tina said there are some funds. Her understanding is that Brian wanted her to have a little money
- to help pay the expenses while she is there, but it's not enough to keep the airport going in
- perpetuity. In her role as executor of the estate, there are things that she will dispose of, not
- valuable or integral to the airport. Her intent is to help keep the place going with any money that
- comes from disposing of things, not to use the money personally.
- 14 Steve Tofel suggested that we might want to form a committee to gather more information, and
- possibly consult with the town attorney. This is a wonderful thing that Brian wanted to leave this
- to the town and Tina. This might consist of the Town manager, one or two members of the
- 17 Selectboard, Tina and a few people that know something about operating an airport.
- 18 Tina said there is a small group of people who are operating the airport now, and thought those
- 19 people would be important, along with representation from the glider club. Brian had also left a
- 20 note suggesting that community members and perhaps someone interested in the arts, and
- 21 education should be included.
- 22 Sharon wondered if a preliminary step would be for the Selectboard and Town Manager to meet
- 23 with the town attorney to pick his brain about the kinds of things we should think about before
- making the decision of whether to accept the airport. Then if it looks like we're given the go
- ahead to explore this we would have the larger group that you are talking about. Steve agreed, Li
- added that there isn't any rush to make a decision. The town needs to make sure its interests are
- 27 protected concerning liability and also, the airport did generate taxes.
- 28 Tina said the intent was to keep paying the taxes. What we have been wondering is whether it
- would be possible for the town to accept the airport but have the operation at a minimum, and
- then potentially the operation and maybe ownership could go to a non-profit or other
- 31 organization that would then be able to pay the taxes and relieve the town of any liability.
- Tina said she didn't think it was Bryan's intent to have the airport be a burden to the town, but
- rather his hope was that by leaving it to the town it would remain a community resource.
- Mary Bryant said she thinks Thetford is really lucky to make claim of having its own little
- airport, glider club and hot air balloons. That is really unique. Mary said she is touched that
- 36 Brian left it to the town. It is an amazing gift. Mary appreciates the fact that fellow Selectboard
- 37 members are thinking very practically as we must, but she is also hearing about this group of
- people and wondered if they had met yet. What would they like to have happen?
- Tina said that the people who are interested in the day-to-day management of the airport have
- met. There has not been one big meeting with everyone though.
- 41 Mary said it is an exciting moment, and she would like to see the town proceed with the
- 42 responsibility of making a wise decision, as well as hearing more of what people would like to
- 43 see happen. More ideas give us more possibilities.

- 1 Li Shen said there is a model in Thetford with the Upper Valley Fish & Game Club, which leases
- 2 property owned by the town, and they do assume liability for all their actions on that property.
- 3 The details are in the lease, so the town could own it, but then lease the whole thing under an
- 4 agreement that incorporates all of the things Tina mentioned. The town does not want to be in the
- 5 business of running an airport.
- 6 Dan Mullen said that looming over all of this is the probate court and the judge, who ultimately
- 7 has the say on how the property can be distributed. Tina just became the executor, and there is a
- 8 sixty-day time period for Tina to determine what the estate is comprised of. That information
- 9 will come together slowly and once that's done, there is an open time period to administer the
- 10 estate. Attorney Mullen said there was no rush, and the town should take as much time as
- 11 needed. Tina added that it was really important for her to get this right, or as close as she can. In
- her mind, that means taking the time to think about it and getting input from others.
- 13 Sharon asked Attorney Mullen if he had any sense of how slowly or quickly the probate court
- might work. Would it be months or years?
- 15 Attorney Mullen said it depends on each estate. There are set timelines by statute, such as 60
- days from when an estate is opened to file an inventory. An extension of that time can be
- 17 requested. Currently the courts are pretty burdened, due to a backlog of cases from COVID-19.
- An estate can be kept open for a very long time, as long as you have a reason to do so. Tina said
- she has already requested an extension for the inventory.
- 20 Bryan Gazda said the best way forward might be for he, the town attorney, Attorney Mullen and
- 21 Tina to meet to discuss the will. Bryan has not seen a copy of the will yet. The four could sit
- down and do some of that preliminary work. Bryan has heard from the insurance carrier, and
- 23 this is not something that would be covered through VLCT. The town would have to look
- elsewhere for insurance. Bryan's recommendation to the Selectboard is to allow some time for
- 25 Bryan to look through the documents and for the attorneys to start a conversation. Then they can
- 26 report to the Selectboard as to what is and is not feasible.
- 27 Tina said we need to really understand what the possibilities are, so she is open to that
- 28 suggestion.
- Greg Hanlon said he is president of the Post Mills Soaring Club and is a resident of Lyme, NH.
- 30 He is very encouraged that everyone is open minded about this. This is a really unique gift and
- 31 Thetford is really lucky to have this airport and to potentially own it. Small airports like this are
- disappearing around the country at a really rapid rate, as are soaring clubs as a result. The Post
- 33 Mills airport is unique among a unique subset.
- 34 Sharon asked if the Selectboard could give the group some questions that they would like to see
- answered by our attorney. Bryan said they could forward them to him and he would get them to
- 36 the attorney. Attorney Mullen will send Bryan a copy of the will.
- 37 The Selectboard was in agreement to task the Town Manager, Bryan Gazda, to meet with Tina
- Foster, Dan Mullen, and the Thetford town attorney to discuss the Post Mills airport.

# 6. Treasure Island Exploratory Committee's End of Year Report and New Fundraising Project

David Roth gave an overview of the committee's inception and their original charge. David said it has been an extraordinary and accomplished year, and committee members are proud of the work they have done.

- 1 Doug Tifft did a brief review of the annual report (included in the meeting packet). The
- 2 committee has been considering ways to first add value to Treasure Island, and then consider
- 3 ways of reducing costs. They have looked beyond just a place to go swimming but have
- 4 investigated opportunities to have activities through multiple seasons. Doug talked about the
- 5 possibility of partnering with different groups, including some of the camps on the lake.
- 6 In the report, the committee has offered eight different proposals for the Selectboard to consider
- 7 as the next focus for the committee.
- 8 Lucas Stepno said he spends a lot of time at Treasure Island with his 7-year-old son, who loves
- 9 to swim, and play with trucks in the sand. Lucas spoke about a new Treasure Island sign that
- would make it easier for people to find the facility. (Image of design in meeting packet) Lucas
- said they reached out to Katherine Babbott-Ward, as they were impressed with the work she did
- on the sign for Sayre Bridge on Tucker Hill Road. The new sign design reinforces the fact that
- 13 Treasure Island is a public beach, and the committee adopted the loon as a mascot.
- 14 Mary Bryant said she thought the design was stunning.
- David Roth said they had great success with fundraising for the salary of the beach manager, so
- their intent is to fundraise for the sign.
- 17 Sharon Harkay said she has had the privilege of being the liaison to this committee. There is true
- joy, passion, and dedication in the committee for building up Treasure Island. Sharon noted that
- 19 the town is really lucky to have them serving on the committee. In terms of different proposals,
- Sharon asked if they continue to work on the master plan, couldn't the other 7 points be
- 21 incorporated.
- Li Shen said she saw specific mention in their report of getting the other towns involved who
- also benefit from Treasure Island and would welcome the idea of involving all the three towns.
- 24 (Fairlee, West Fairlee, Thetford) Li noted that less than half of the attendance at Treasure Island
- 25 is Thetford Residents. The rest come from other towns. She is also interested to see what they
- 26 would come up with for extended seasons or year-round use.
- 27 The Selectboard briefly discussed the building at Treasure Island.
- Alexis Jetter thanked the committee and the Selectboard for really considering the potential of
- 29 Treasure Island. She suggested reconsidering the idea of having a year-round caretaker, a
- 30 previously successful model for the facility.
- 31 Steve Tofel said the concerns about that building have been discussed for some time, and he
- would like to see a deadline for a decision on what to do with it.
- Bryan said an inspection had been done on the building shortly after the former caretakers left,
- and there are modifications that would need to be made to become a rental property again.
- 35 It was agreed that the master plan for Treasure Island should be the priority.
- The Selectboard thanked the committee for their work and their report.

# 7. Municipal Planning Grant Applications

- David Forbes gave a brief overview of the municipal planning grant process using the Cares Act Money. Two Rivers Ottauquechee Regional Commission feels that a consortium of towns would

- 7 Municipal Planning Grant Program for the purpose of modernizing our zoning bylaws, to
- 8 authorize the Planning Commission to serve as the agent for the Town of Thetford, and to accept
- 9 Kevin Geiger of Two Rivers Ottauquechee Regional Commission as the grant administrator.
