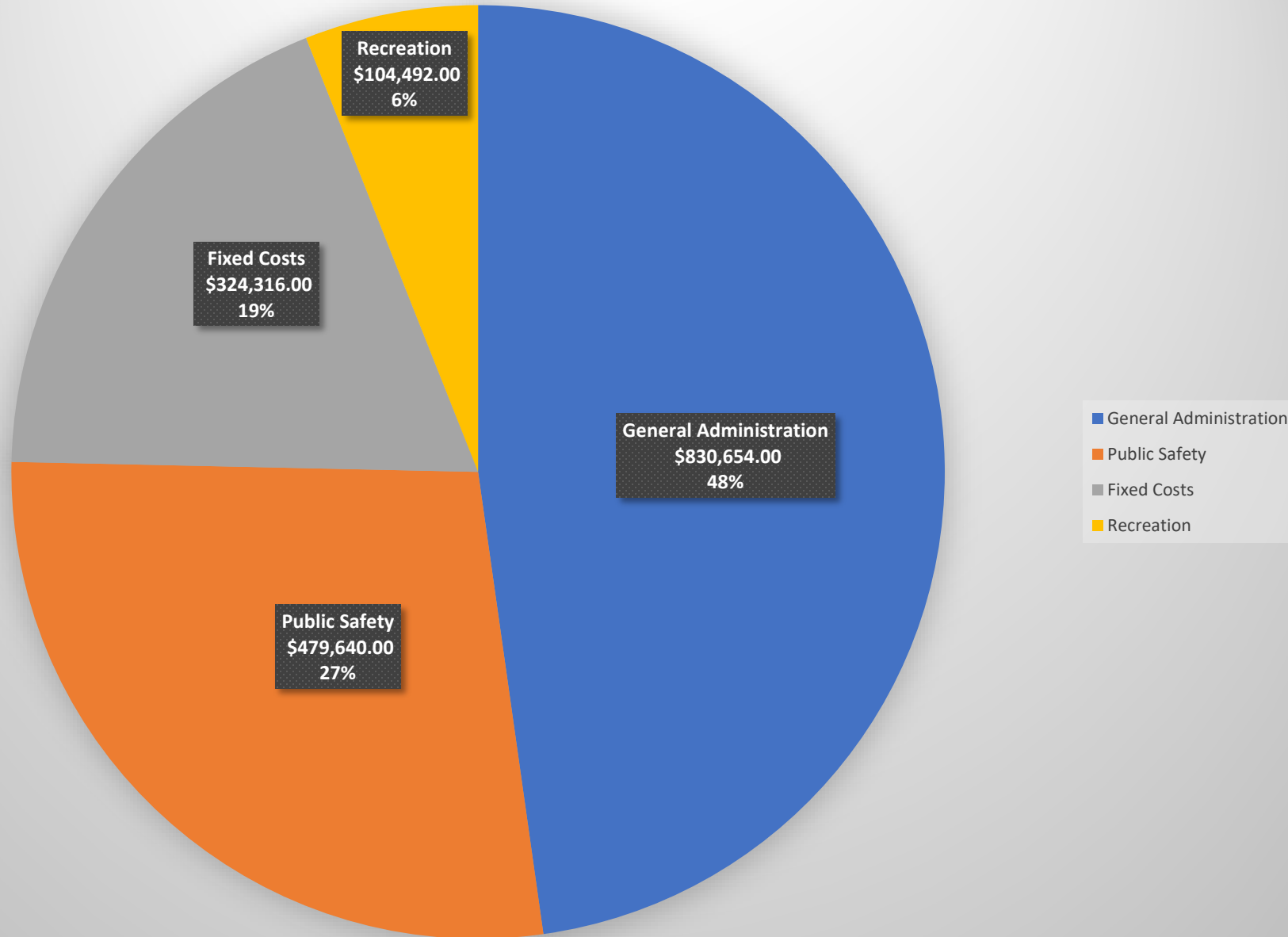

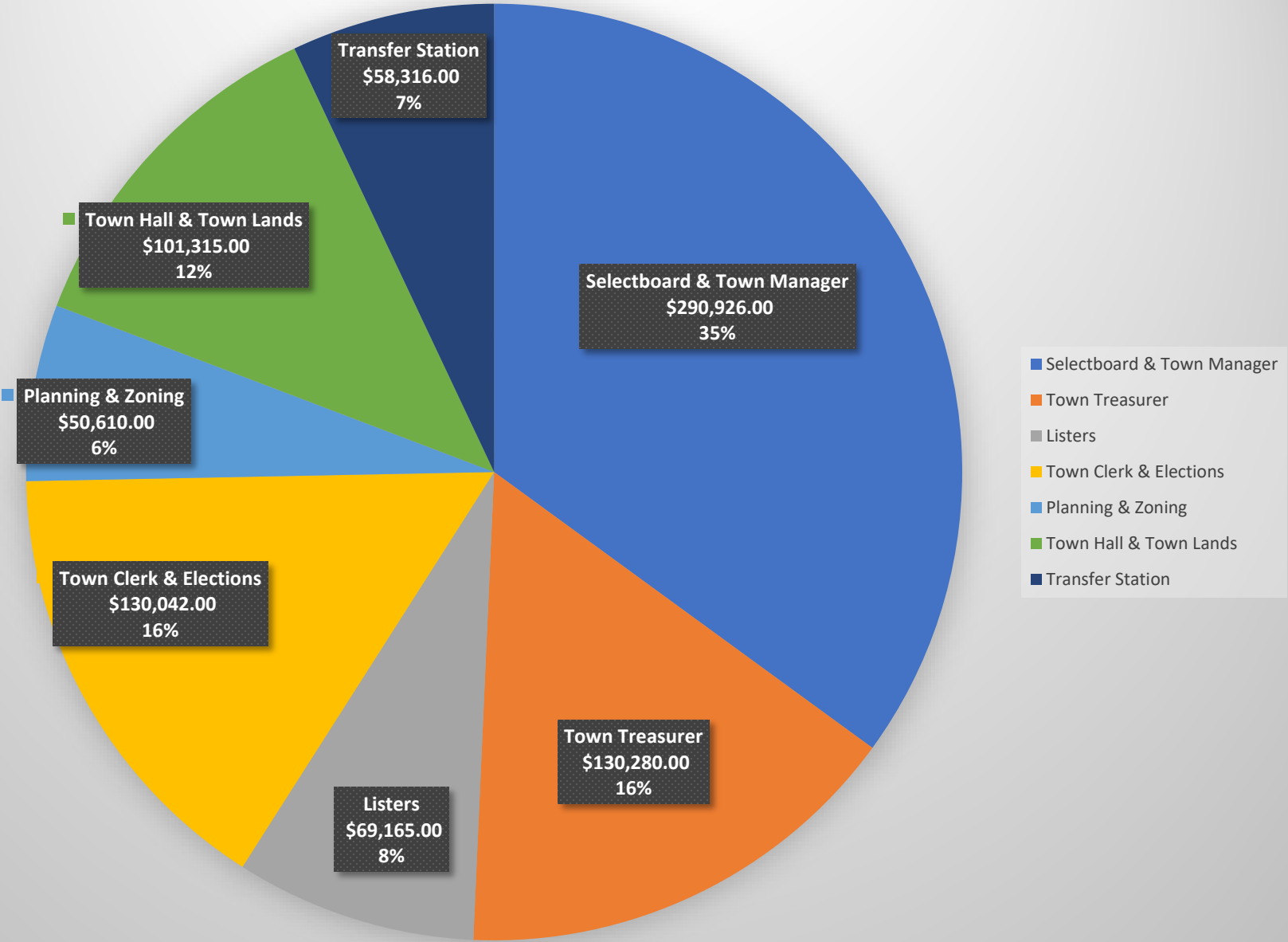

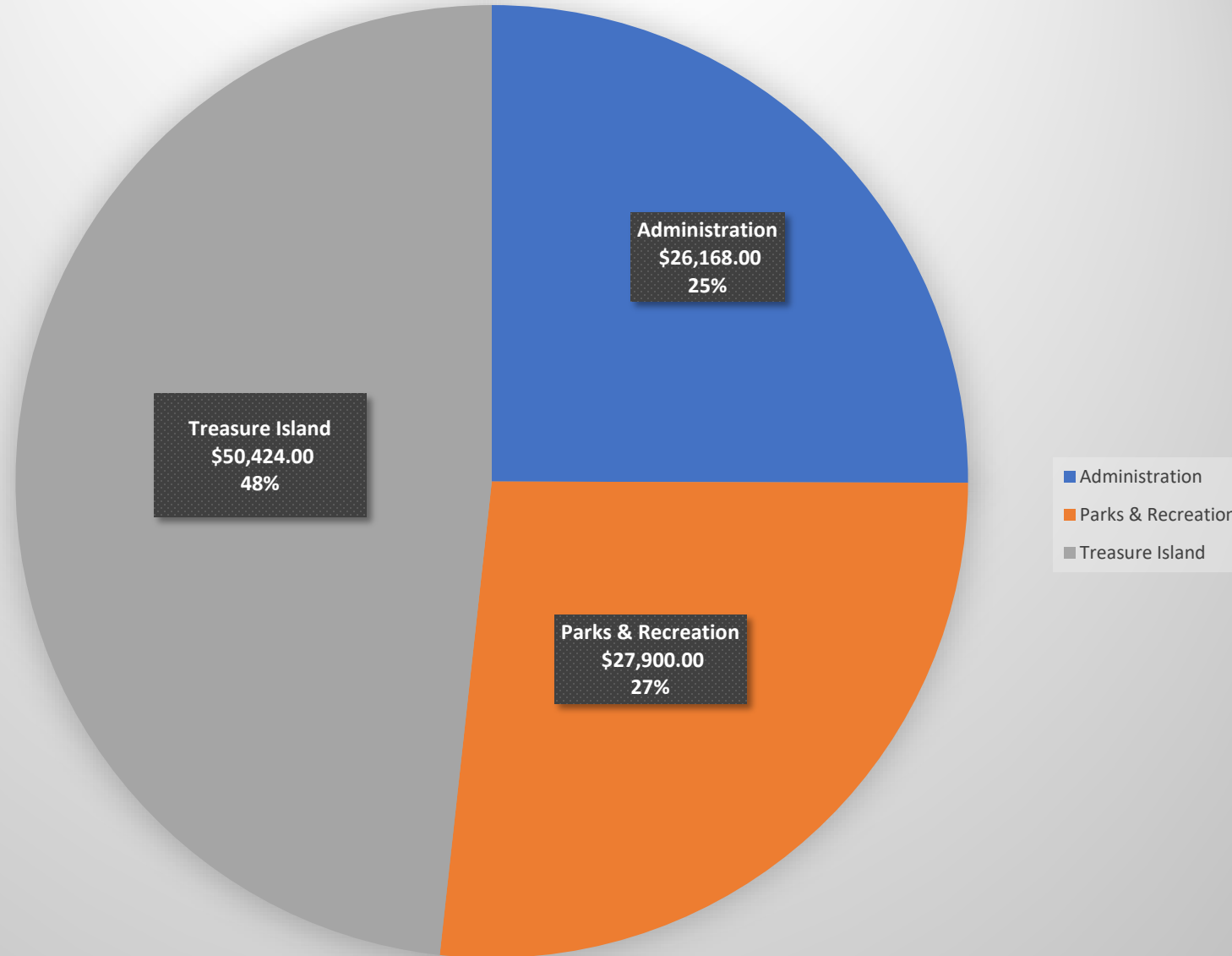
## 2022 GENERAL FUND EXPENSES



# 2022 GENERAL ADMINISTRATION EXPENSES

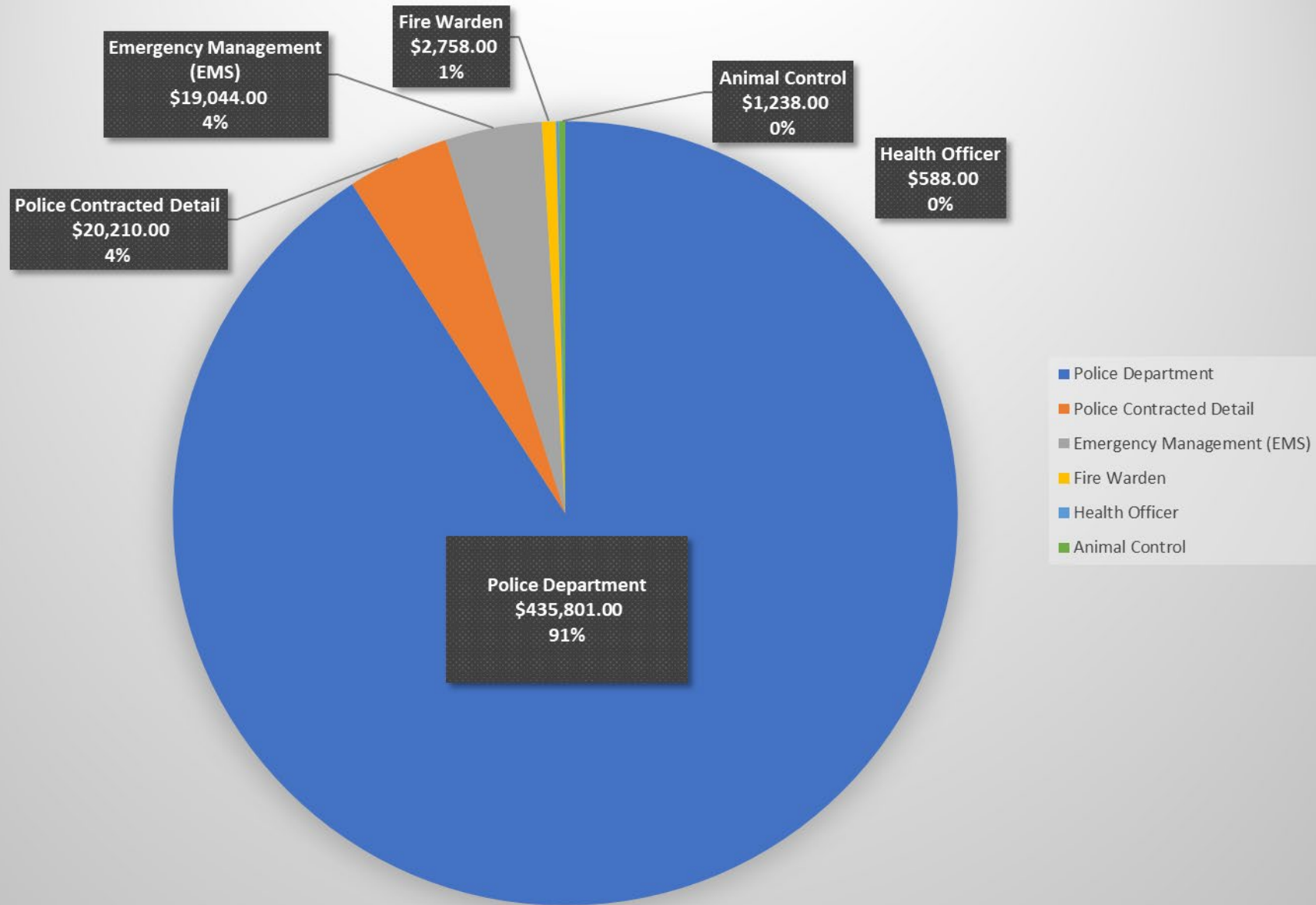


## 2022 RECREATION & TREASURE ISLAND EXPENSES

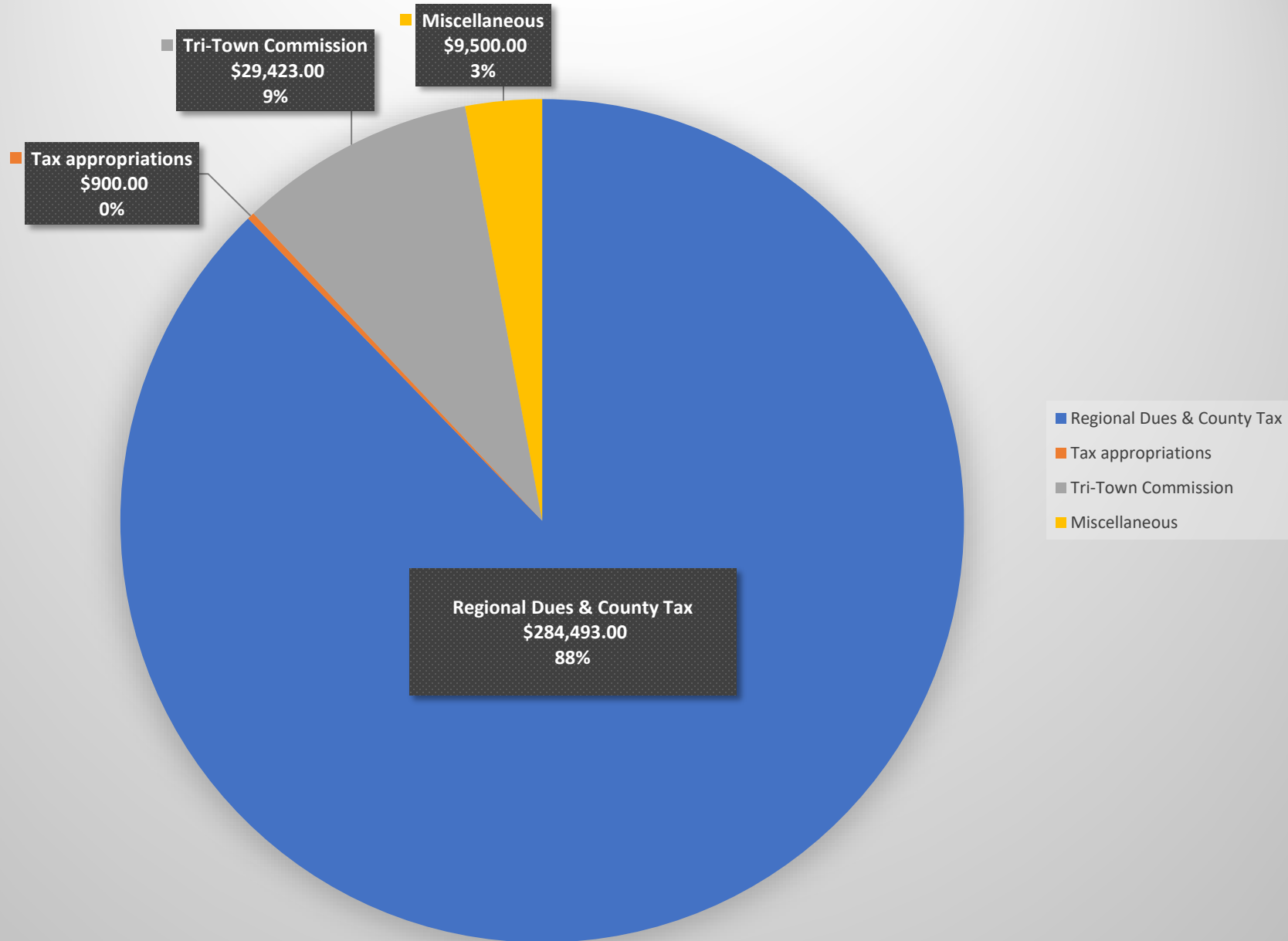




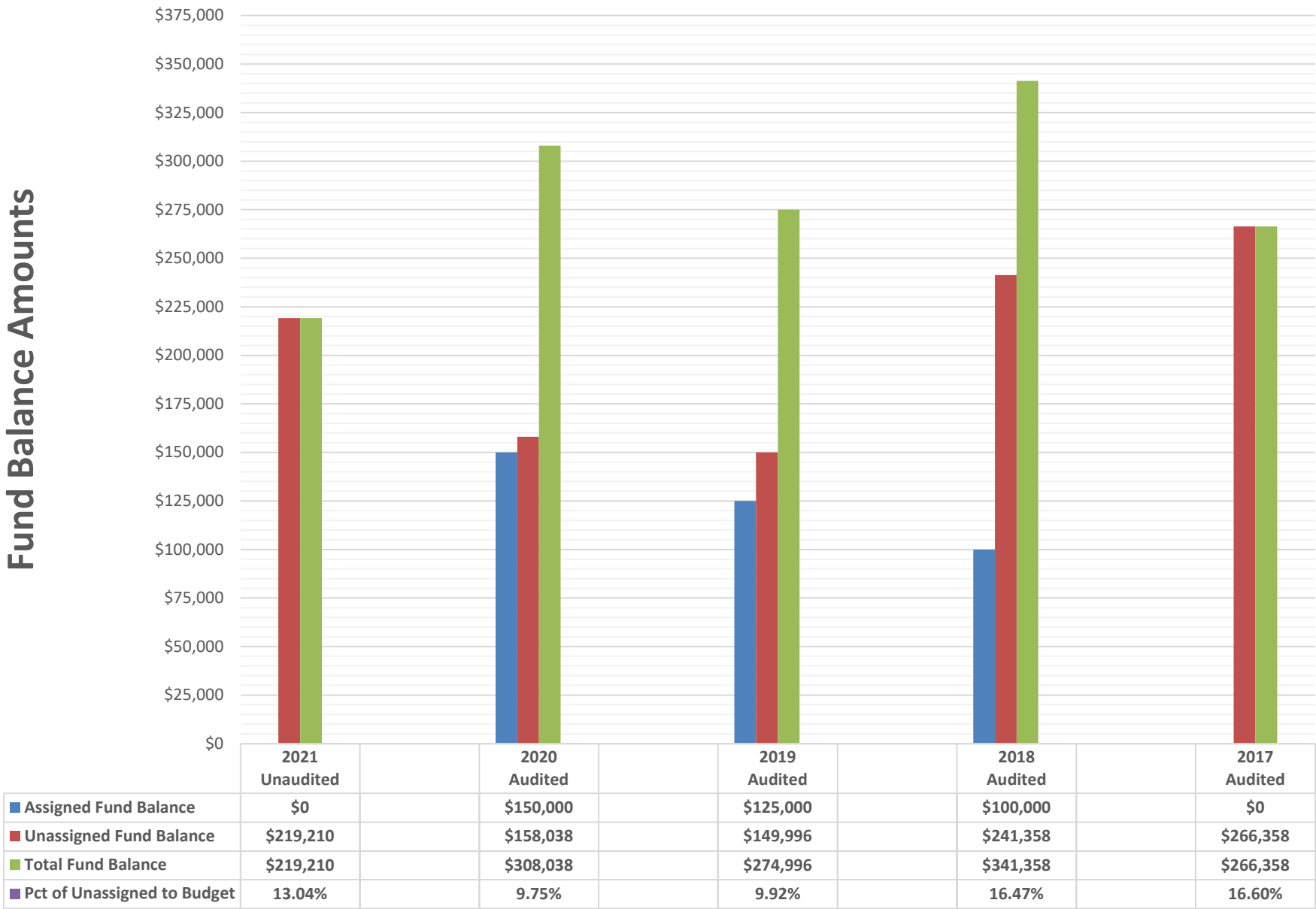
## 2022 PUBLIC SAFETY EXPENSES

# General Fund Balances 2017-2021



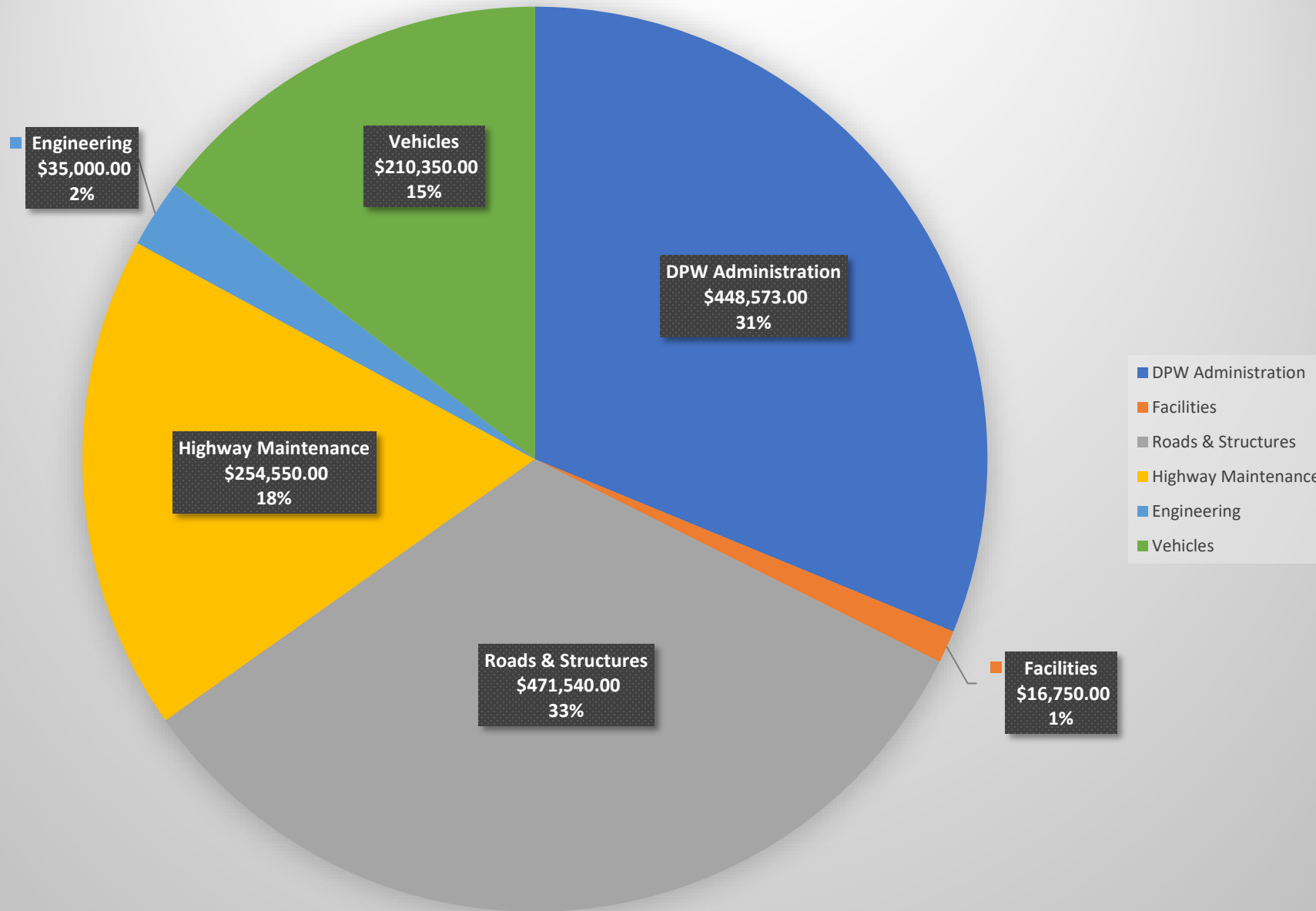
# TOWN OF THETFORD

## *Article 4:*

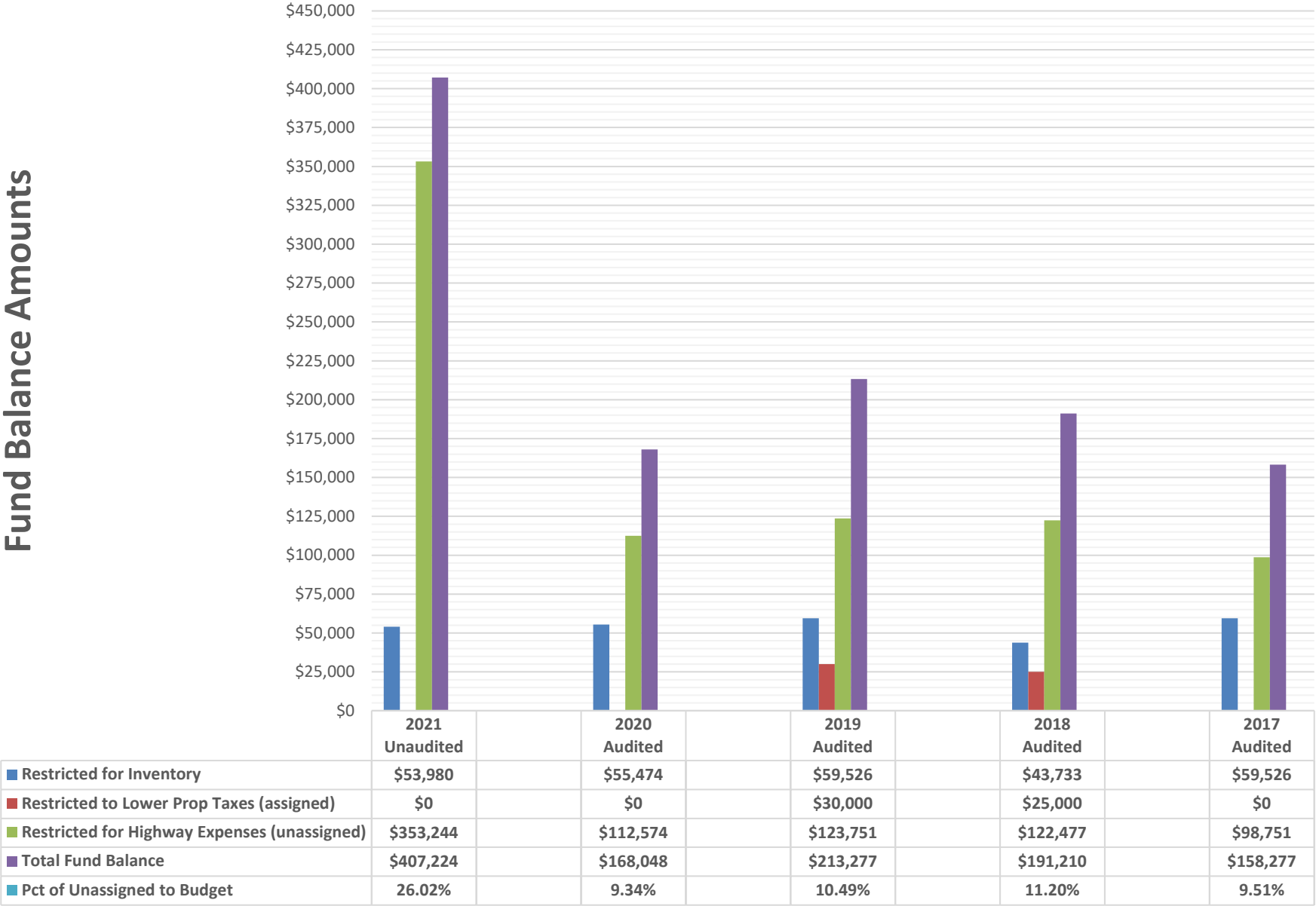


## 2022 DEPARTMENT OF PUBLIC WORKS EXPENSES
