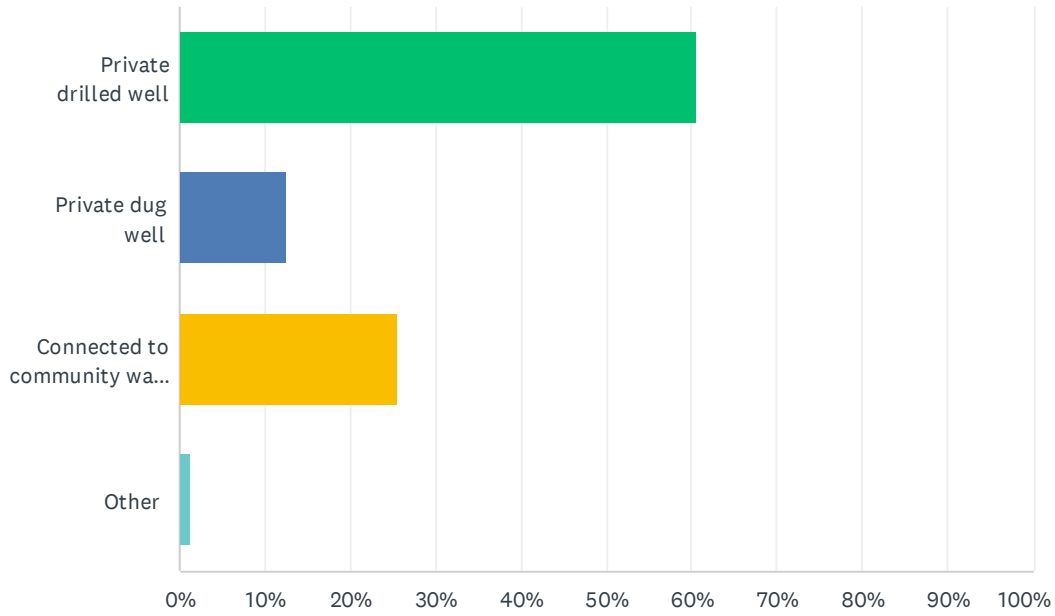


# Q1 What is your current water source?

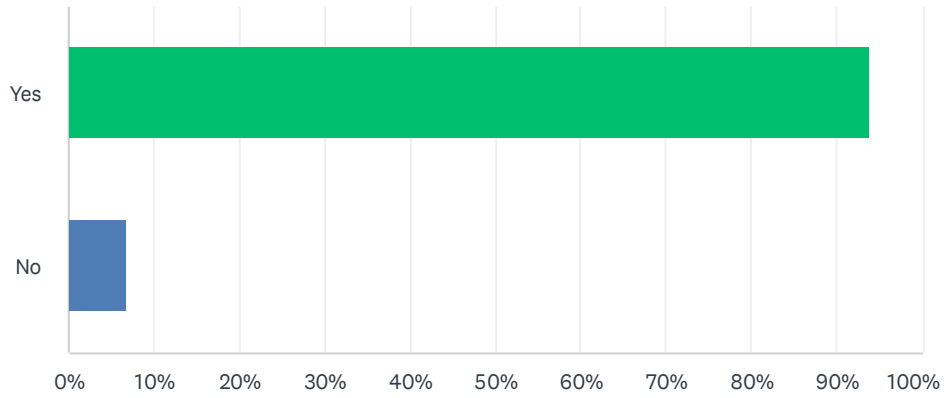

## Q2 Does it supply enough water year-round?

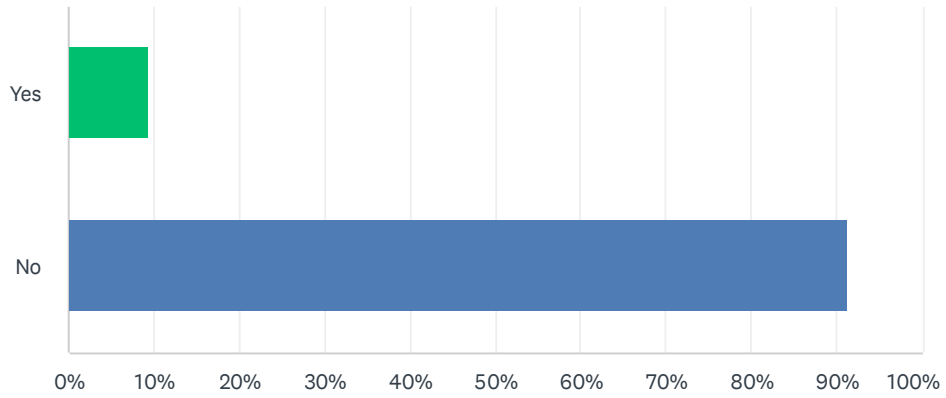

### Q3 Does it cost too much?

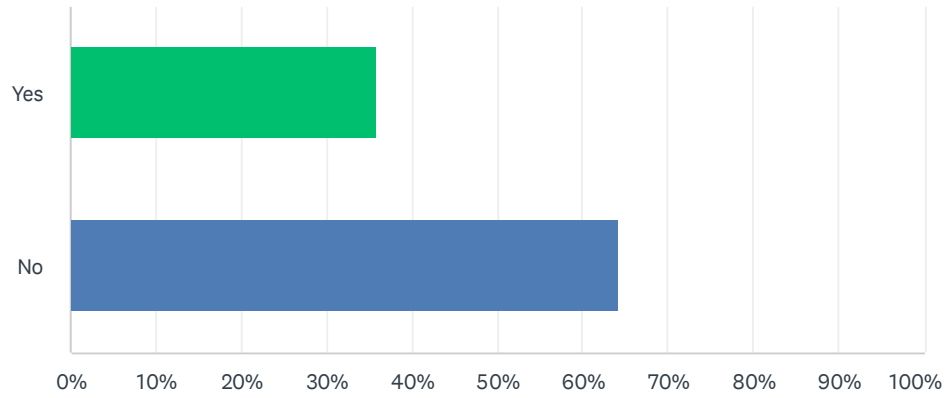

### Q4 Are you concerned about the water quality?

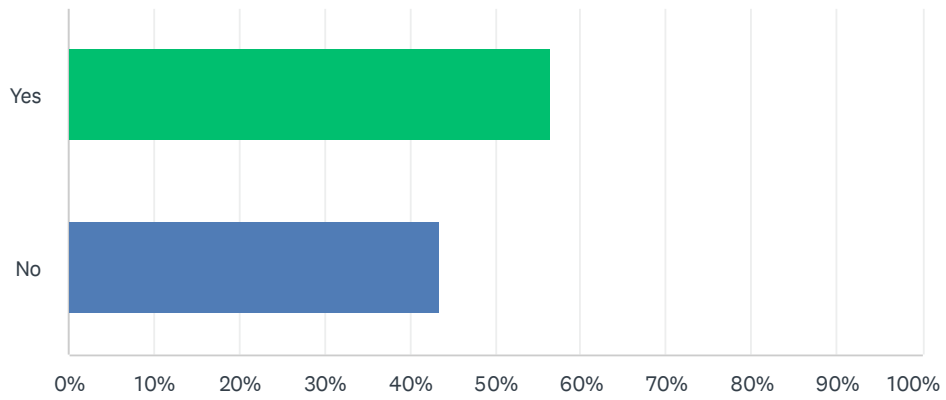

### Q5 Does it require treatment or filtration?

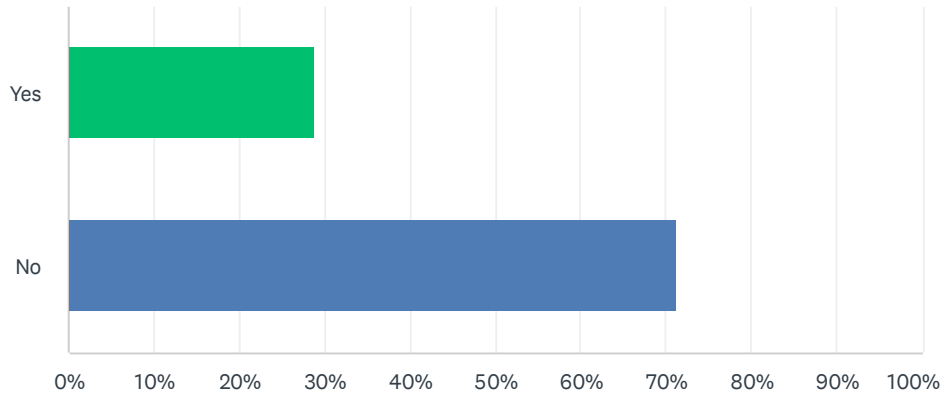

### Q6 Do you regularly test your water?

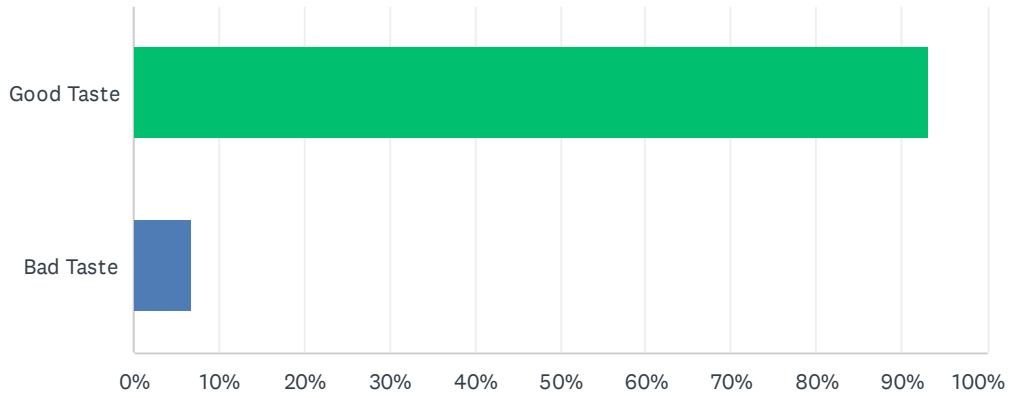

### Q7 Does it have a good or bad taste?

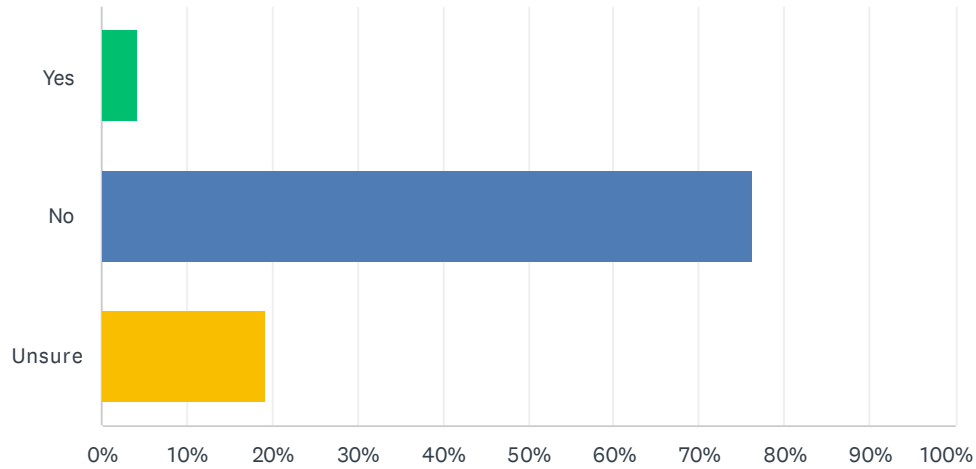

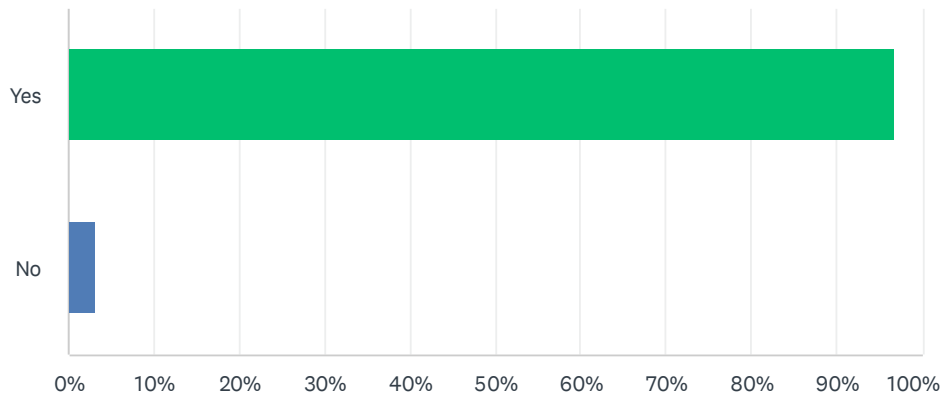

# Q10 For Private Well Users - If your well failed would you replace it?

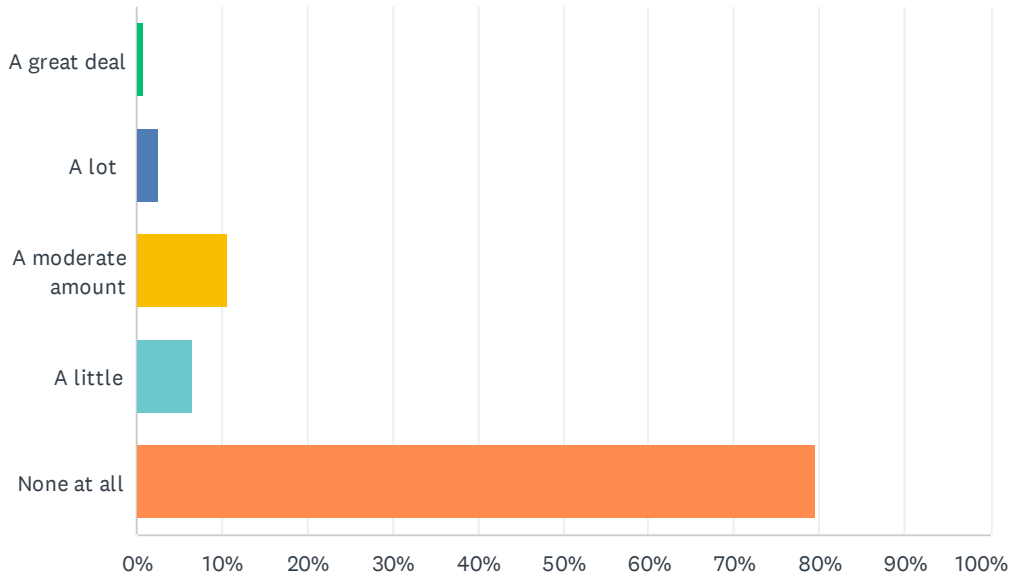

# Q11 For Private Well Users - Do you feel being on a well limits your property resale value?

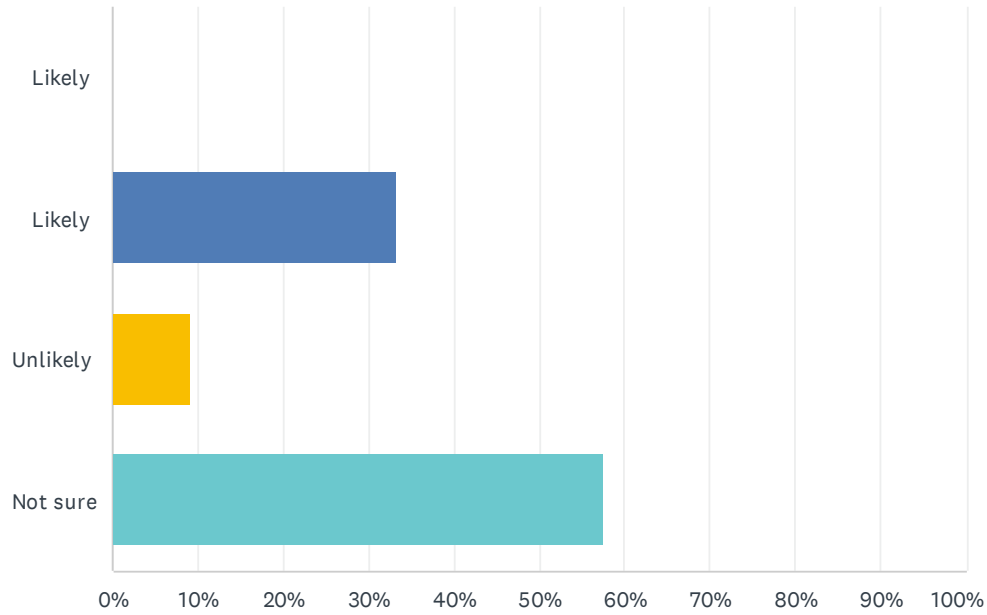

## Q12 For Private Well Users - If you wanted to subdivide, could you obtain the requisite water?

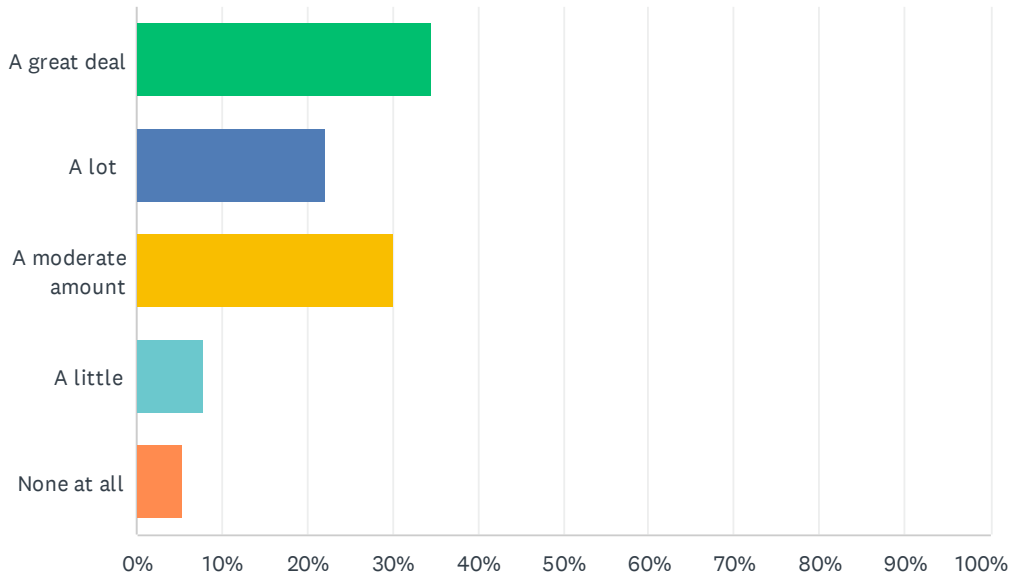

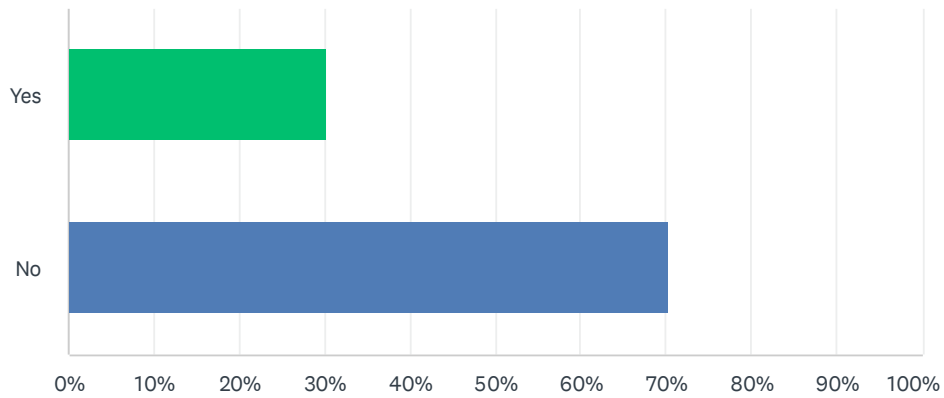

# Q14 Would you prefer to be on a municipal water system?

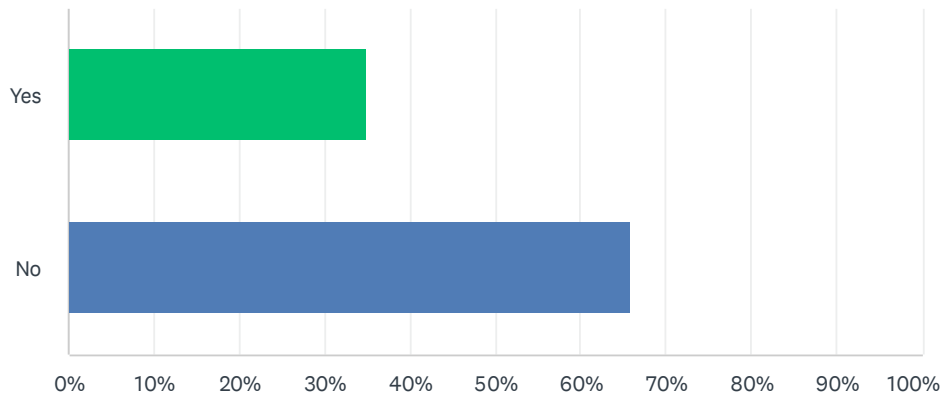

# Q15 Would you pay more for a municipal operated system?

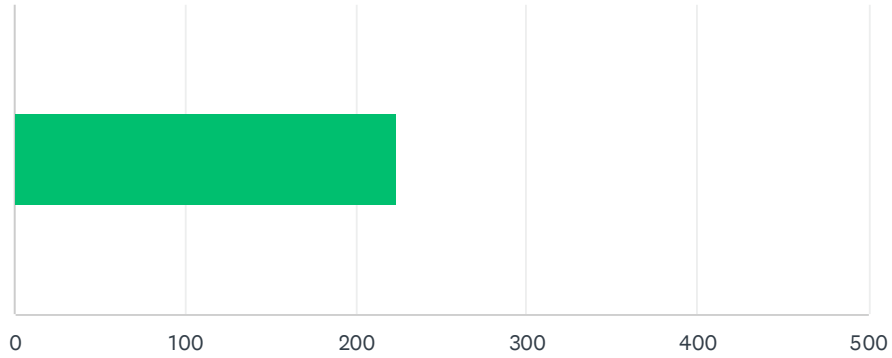
