TES Solar

- TES Solar update from Nolan:
 - due to the fact that we would be transferring the RECs, the VLS Energy Institute will not work with us. I need to update the TES school board on the circumstances, and see

what their opinion is moving forward. No word from the PUC either way. I'd like to contact GMP to see if they would administer the array, but would need to okay that with their counsel before doing so. I'm hoping to hear word from the PUC before I do.

Weston potentially to develop a new solar array in Thetford in which he would work with the town for discounted net metering credits and potentially use local low-moderate income households as well.
