## Selectboard Regular Meeting Minutes Thetford Town Offices (w/Virtual Attendance Option)

Sharon Harkay called the meeting to order at 7:00 PM.

### 1. Agenda Review

Sharon said she would like to add an item reaffirming the retirement plan for Chief Scruggs after public comment. All agreed.

## 2. Notes from the Selectboard Chair

Sharion said there has been a resignation from the Planning Commission. Cynthia Shelton submitted her resignation effective September 15<sup>th</sup>, 2023. Sharon thanked Cynthia for her time of service. The position needs to be filled with a term ending in 2025.

### 3. Town Manager Report – Brian Story

Brian updated the Selectboard on the preparations for winter being made by the Department of Public Works.

Work is being done on scheduling a drug take-back day for prescription drugs.

Brian wanted to bring the Board's attention to the contract for the reappraisal services. The Board has already approved the contract, but Brian thought they might want to review the wording.
